1. Market overview

- Both RSI and ALSI went down 0.38 and 0.06 points to close at 123.02 and 135.52 respectively.
- Today's trading session recorded a total of Frw 167,819,000 Frw from 2,411,700 shares traded in 6 deals and Frw 26,741,900 worth of bond traded in 3 deals.
- CTL counter closed at Frw 65 (Frw 70 previous). The trading session recorded a total turnover of Frw 167,819,000 from 2,411,700 shares traded in 6 deals.
- Equities counters closed as follows: BOK: Frw 265; BLR: Frw 139; IMR: Frw 90; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

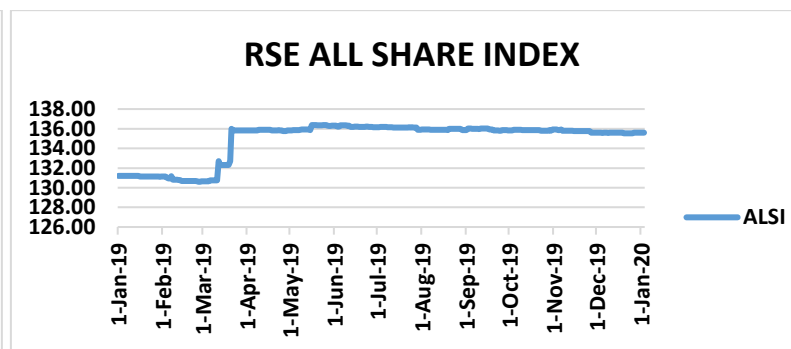
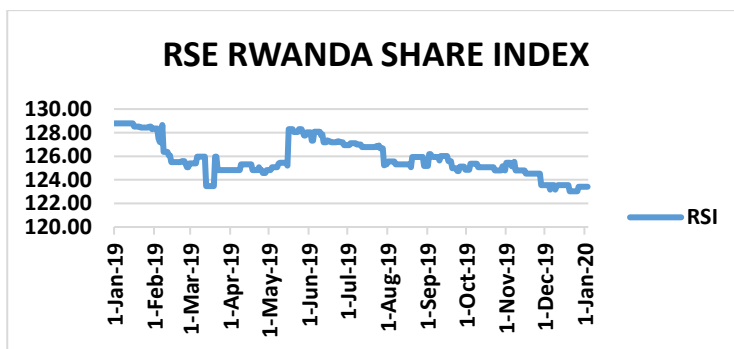
