



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 15TH MARCH 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 10,247,000 worth of bonds traded in 5 deals on the fixed-income market and Frw 8,137,000 from 41,100 shares traded in 6 deals on the equities market.
- RSI and ALSI remained constant to close at 110.15 and 142.89 respectively.
- MTNR counter closed at Frw 174 (Frw 174 previous). The trading session recorded a total turnover of Frw 2,697,000 from 15,500 shares traded in 2 deals.
- BOK counter closed at Frw 271 (Frw 271 previous). The trading session recorded a total turnover of Frw 2,710,000 from 10,000 shares traded in 3 deals.
- BLR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 2,730,000 from 15,600 shares traded in 1 deal.

- Equities counters closed as follows: IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 43,100 shares between Frw 271 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,290,100 shares between Frw 174 - 180 and no bids. On BLR counter, there was an outstanding bid of 400 shares at Frw 160 and an outstanding offer of 4,400 shares at Frw 175. On IMR counter, there were outstanding offers of 245,400 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 24,100 shares between Frw 122 - 125 and no offers.

On the bonds market, there were no offers and no bids.

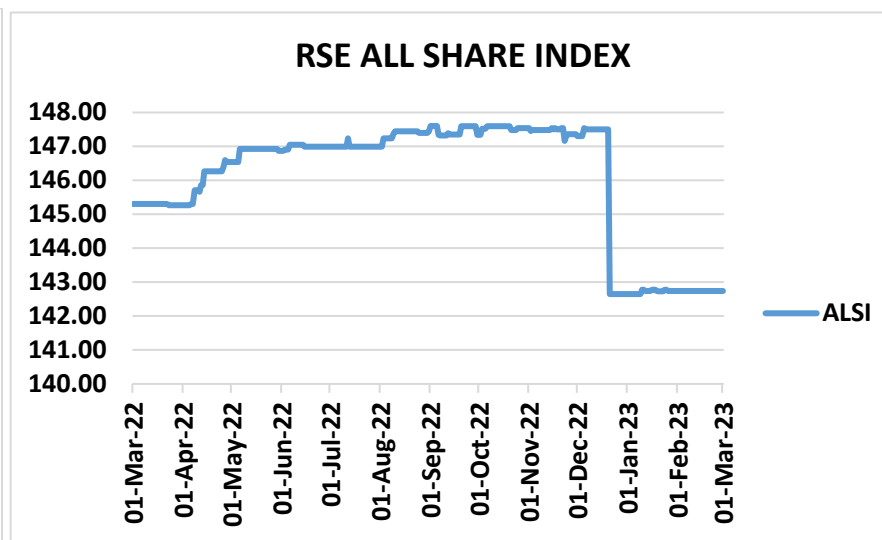
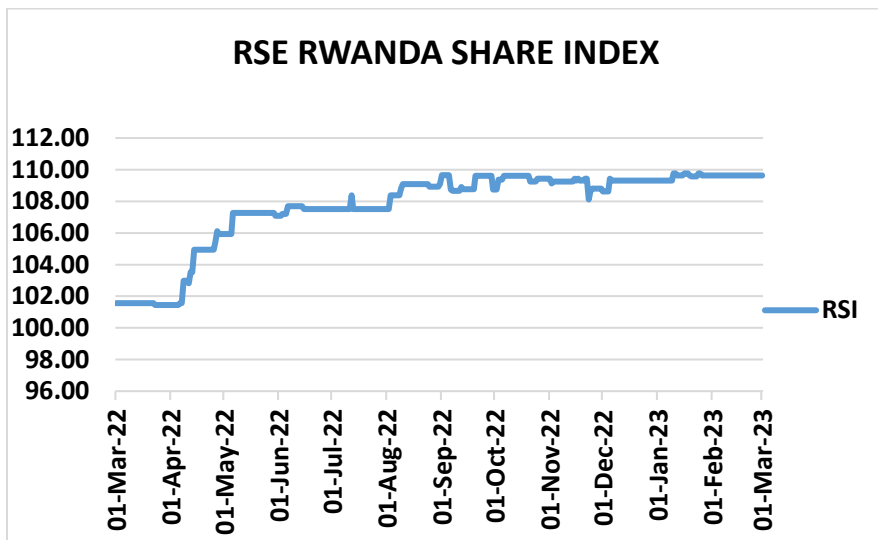
