



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 17TH MAY 2023

1. Market overview

- The trading session recorded a turnover of Frw 1,442,500 from 6,600 shares traded in 4 deals on the equities market and Frw 1,030,000 worth of bonds traded in 1 deal on the fixed-income market.
- RSI and ALSI remained constant to close at 112.97 and 143.69 respectively.
- BOK counter closed at Frw 280 (Frw 280 previous). The trading session recorded a total turnover of Frw 1,120,000 from 4,000 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 40,500 from 900 shares traded in 1 deal.
- BLR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 216,000 from 1,200 shares traded in 1 deal.
- CMR counter closed at Frw 132 (Frw 132 previous). The trading session recorded a total turnover of Frw 66,000 from 500 shares traded in 1 deal.

- Equities counters closed as follows: MTNR: Frw 173; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 553,800 shares between Frw 172 - 180 and no bids. On IMR counter, there were outstanding offers of 225,700 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 5,500 shares at Frw 180 and no bids. On CMR counter, there was an outstanding offer of 95,500 shares at Frw 132 and no bids.

On the bonds market, there were outstanding offers of Frw 23,000,000 worth of bonds at Frw 102.5 and no bids.

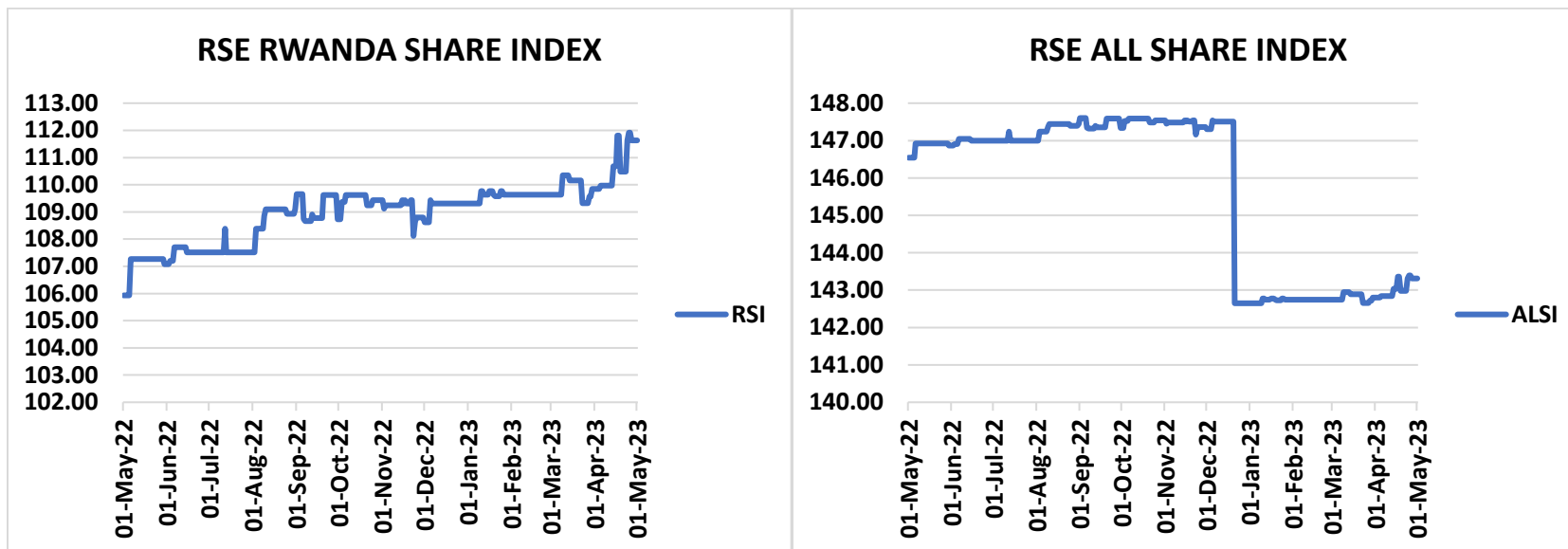

6. CORPORATE NEWS

- **Bralirwa Plc:** a cash dividend of Frw 21.91 per share (2021: 17.03) will be proposed to the Annual General Meeting of Shareholders on 5th June 2023. If approved, the proposed dividend will be paid on 30th June 2023. The dividend is equal to 100% of the net profit for the fiscal year 2022 and it is subject to withholding tax. Bralirwa shares will have a book close date of 31 May 2023, which means that the final dividend will be paid to all shareholders whose names appear in the Register of Shareholders at the close of business on 31 May 2023.
- **BK Group Plc:** The Board of Directors has recommended that the Annual General Meeting (the AGM) be held on 19th May 2023. The Board of Directors has recommended a final and full dividend of Frw 32.5 for each ordinary share, on the issued and paid-up share capital of the company at the Annual General Meeting. This represents a 50% pay-out ratio of the Group's Net Income for the year ended 31st December 2022. The dividend will be payable on or around 1st July 2023 to the members of the company on the share register at the close of business on Thursday 22nd June 2023.

- **I&M Bank Rwanda Plc:** The Board of Directors has recommended a dividend payment of Frw 1.84 per share, subject to approval from the Annual General Meeting of Shareholders that will be held on Wednesday 24th May 2023.
- **Equity Group Holdings Plc:** The Board of Directors has recommended a dividend of Kenya Shillings four (Shs 4.00) for each ordinary share on the issued and paid-up share capital of the company for the financial year ended 31st December 2022. Subject to shareholders' approval, the dividend will be payable on or before 30th June 2023 to the members of the Company on the share register of the Company on the closure date of 19th May 2023. A general meeting will be held on 21st June 2023. Details to be communicated in due course.
- **KCB Group Plc:** The Directors of KCB Group Plc (the Group) have recommended a final dividend of KShs 1.00, having paid an interim dividend of KShs 1.00 for each ordinary share on the issued and paid-up share capital of the company subject to shareholders approval. The final dividend will be payable to the members of the Company on the share register at the close of business on Thursday 6th April 2023. If approved, the full dividend per share for the year ended 31st December 2022 will be KShs 2.00 for each ordinary share. KCB Group Plc Annual General Meeting is scheduled on 25th May 2023 via electronic means.
