



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 18TH DECEMBER, 2019

1. Market overview

- It was a quiet market on the Equities side and quiet a busy one on the bond markets.
- The trading session recorded a total turnover of Frw 1,029,058,500 from 2 deals worth of bonds.
- Both RSI and ALSI remained constant to close at 123.54 and 135.61 respectively.
- Equities counters closed as follows: CTL: Frw 70; BOK: Frw 265; BLR: Frw 139; IMR: Frw 90; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

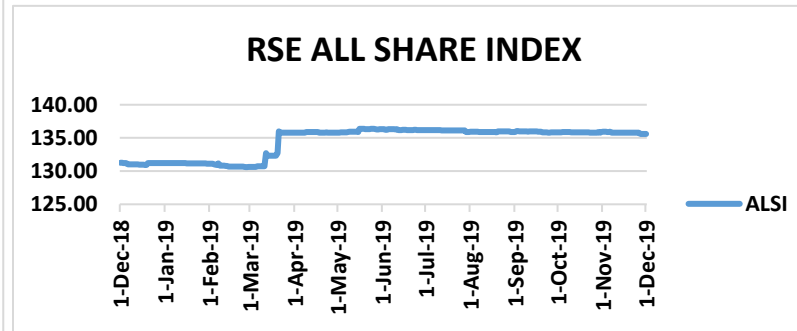
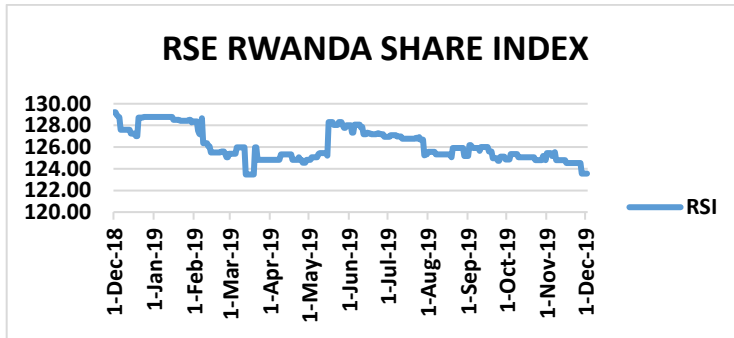
At the end of the formal trading hours, on BOK counter there were outstanding offers of 192,000 shares between Frw 261-275 and no bids. On BLR counter, there were outstanding offers of 712,600 shares between Frw 139-152 and no bids. On CTL counter, there were outstanding bids of 22,200 shares at Frw 65 and outstanding offers of 41,500 shares at Frw 70. On IMR counter, there were outstanding offers of 1,191,400 shares between Frw 90-97 and no bids.
