



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 18TH NOVEMBER 2020

1. Market overview

- Today's trading session recorded on the equities market a total of Frw 7,966,900 with CTL decreasing 1 point to Frw 71 while the fixed income market was quiet.
- RSI and ALSI went down 0.06 and 0.01 points to close at 108.98 and 147.95 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 225,000 from 5,000 shares traded in 1 deal.
- BOK counter closed at Frw 230 (Frw 230 previous). The trading session recorded a total turnover of Frw 5,773,000 from 25,100 shares traded in 1 deal.
- CTL counter closed at Frw 71 (Frw 72 previous). The trading session recorded a total turnover of Frw 1,968,900 from 27,700 shares traded in 1 deal.

- Equities counters closed as follows: BLR: Frw 120; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 175,200 shares between Frw 233-240 and no bids. On BLR counter, there were outstanding offers of 154,000 shares between Frw 122-136 and no bids. On CTL counter, there were outstanding offers of 27,100 shares between Frw 72-73 and outstanding bids of 130,200 shares between Frw 65-70. On IMR counter, there were outstanding offers of 315,500 shares between Frw 45-47 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

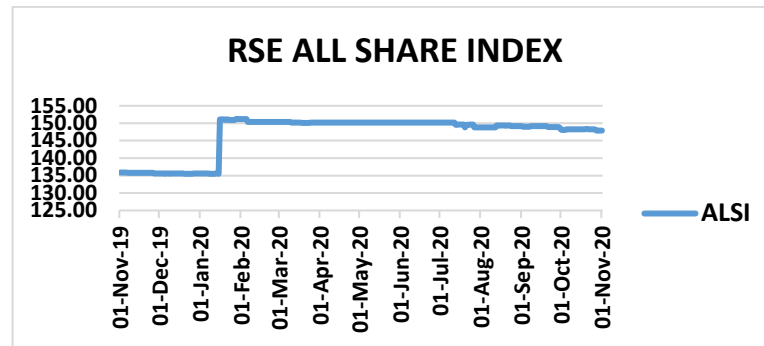
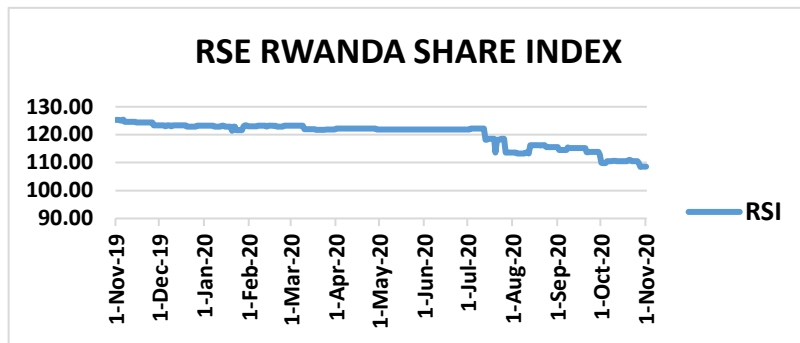
