



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 19TH JANUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 234,955,000 worth of bonds traded in 5 deals on the fixed income market and Frw 256,500 from 5,700 IMR shares traded in 2 deals on the equities market.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 256,500 from 5,700 shares traded in 2 deals.
- Equities counters closed as follows: BLR: Frw 125; BOK: Frw 250; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 41,200 shares at Frw 250 and an outstanding bid of 5,000 shares at Frw 245. On MTNR counter, there were outstanding offers of 550,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 92,600 shares at Frw 125 and an outstanding bid of 10,000 shares at Frw 120. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 493,900 shares at Frw 45 and no bids.

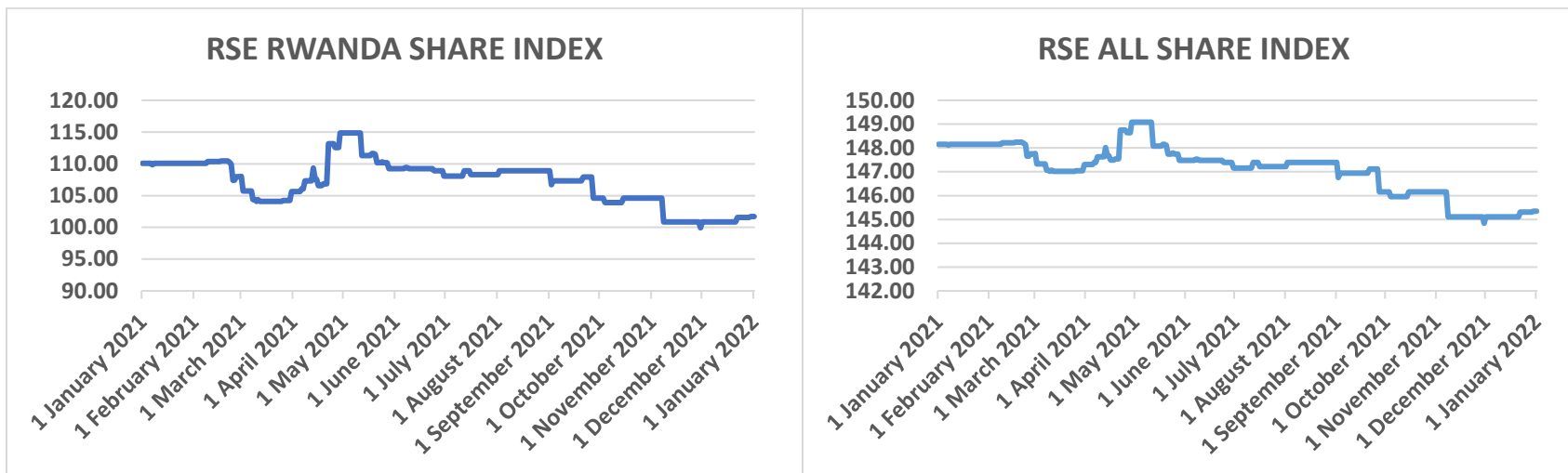
