



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 21ST SEPTEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 4,068,000 worth of bonds traded in 1 deal on the fixed income market and Frw 170,000 from 1,000 BLR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 170,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw: 272; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 375,700 shares between Frw 272 - 290 and an outstanding bid of 1,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,305,200 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding bid of 3,000 shares at Frw 160 and no offers. On IMR counter, there were outstanding offers of 167,900 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 101,500 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

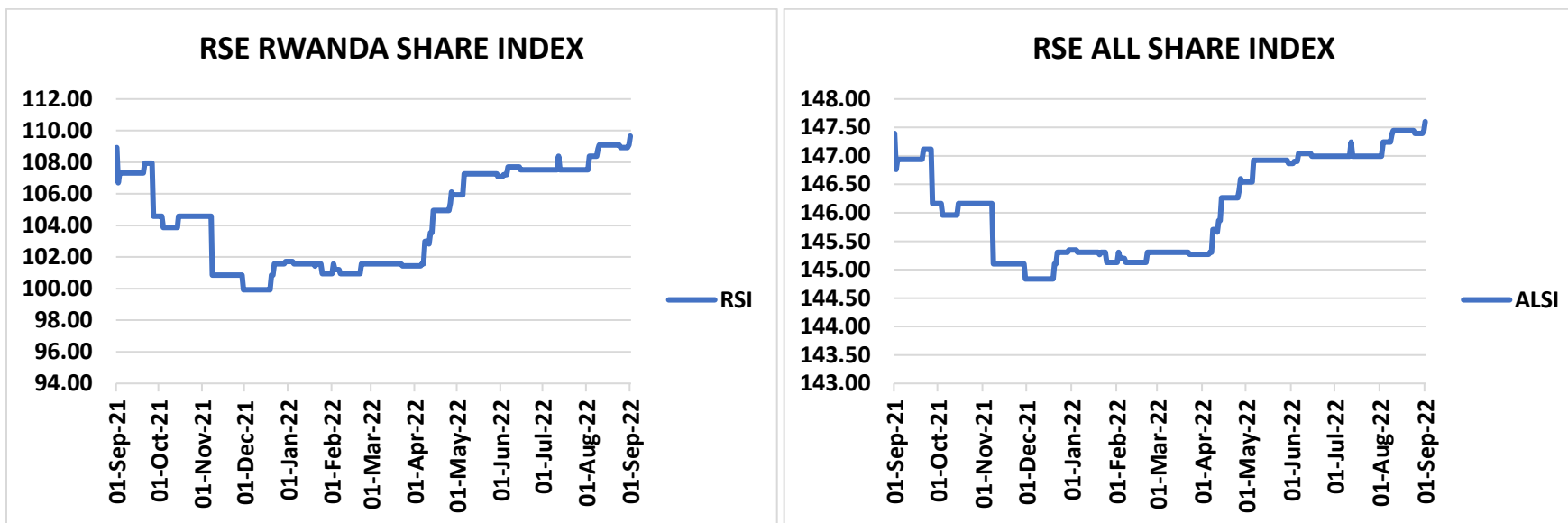
