



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 22ND MARCH 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 70,882,500 worth of bonds traded in 4 deals on the fixed-income market and Frw 22,500 from 500 IMR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 110.15 and 142.89 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 22,500 from 500 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 271; CMR: Frw 120; MTNR: Frw 174; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 43,100 shares between Frw 271 - 280 and an outstanding bid of 25,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,290,100 shares between Frw 174 - 180 and no bids. On BLR counter, there was an outstanding offer of 49,000 shares at Frw 175 and outstanding bids of 20,400 shares between Frw 160 - 170. On IMR counter, there were outstanding offers of 245,400 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 25,100 shares between Frw 122 - 125 and no offers.

On the bonds market, there were no offers and no bids.

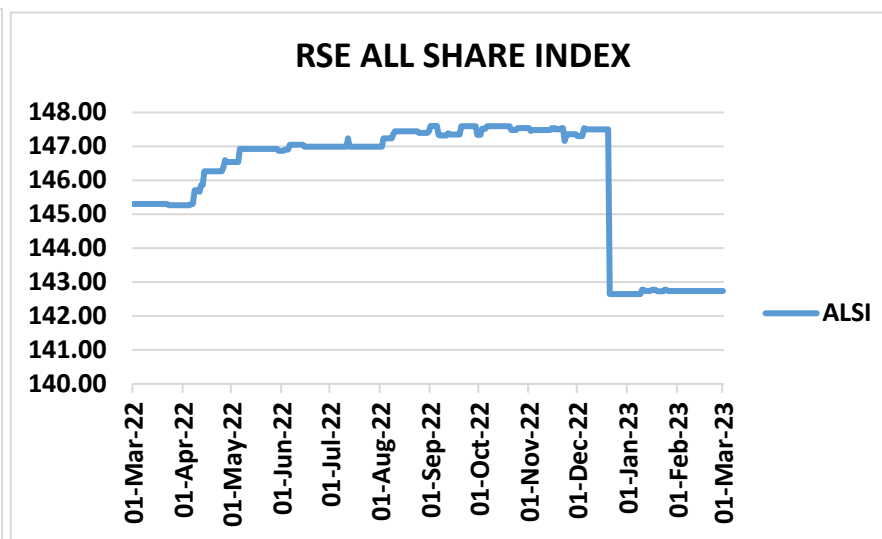
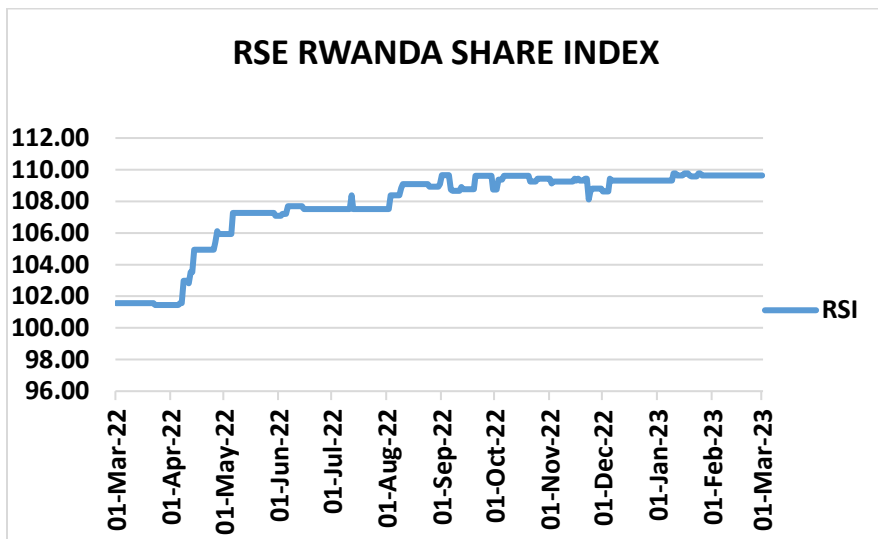
