



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 23RD NOVEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 3,020,214,400 worth of bonds traded in 10 deals on the fixed income market and Frw 52,123,200 from 305,200 shares traded in 3 deals on the equities market.
- RSI and ALSI went down by 1.32 and 0.37 points to close at 108.11 and 147.16 respectively.
- BLR counter closed at Frw 166 (Frw 170 previous). The trading session recorded a total turnover of Frw 48,140,000 from 290,000 shares traded in 1 deal.
- BOK counter closed at Frw 266 (Frw 272 previous). The trading session recorded a total turnover of Frw 3,983,200 from 15,200 shares traded in 2 deals.

- Equities counters closed as follows: IMR: Frw 43; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 84,600 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,224,500 shares between Frw 175 - 180 and no bids. On IMR counter, there were outstanding offers of 257,600 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there were outstanding offers of Frw 8,000,000 worth of bonds between Frw 101.5 - 106 and no bids.

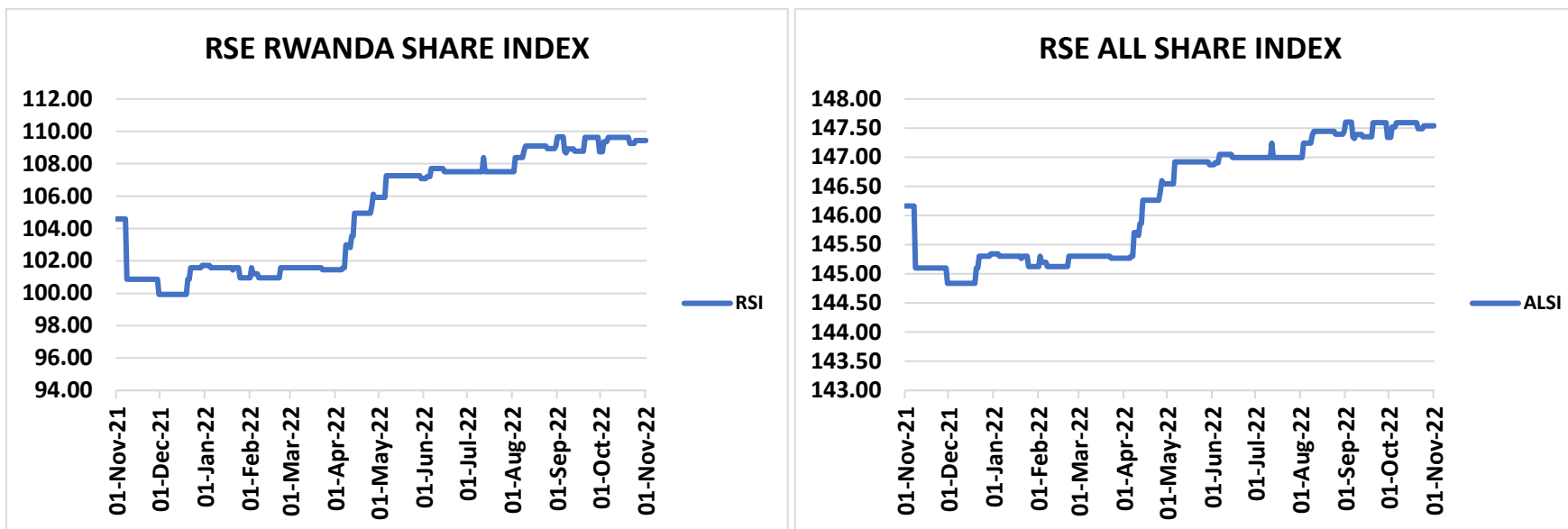
