



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 24TH AUGUST 2022

1. Market overview

- The trading session recorded a turnover of Frw 19,913,500 worth of bonds traded in 5 deals on the fixed income market and Frw 2,480,700 from 11,300 shares traded in 6 deals on the equities market.
- RSI and ALSI remained constant to close at 109.10 and 147.44 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 1,795,200 from 6,600 shares traded in 2 deals.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 445,500 from 2,700 shares traded in 3 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 240,000 from 2,000 shares traded in 1 deal.
- Equities counters closed as follows: IMR: Frw 43; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 365,300 shares between Frw 272 - 290 and an outstanding bid of 22,000 shares at between Frw 245 - 247. On MTNR counter, there were outstanding offers of 910,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 62,700 shares at Frw 165 and outstanding bids of 3,800 shares at Frw 160. On IMR counter, there were outstanding offers of 40,600 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 108,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

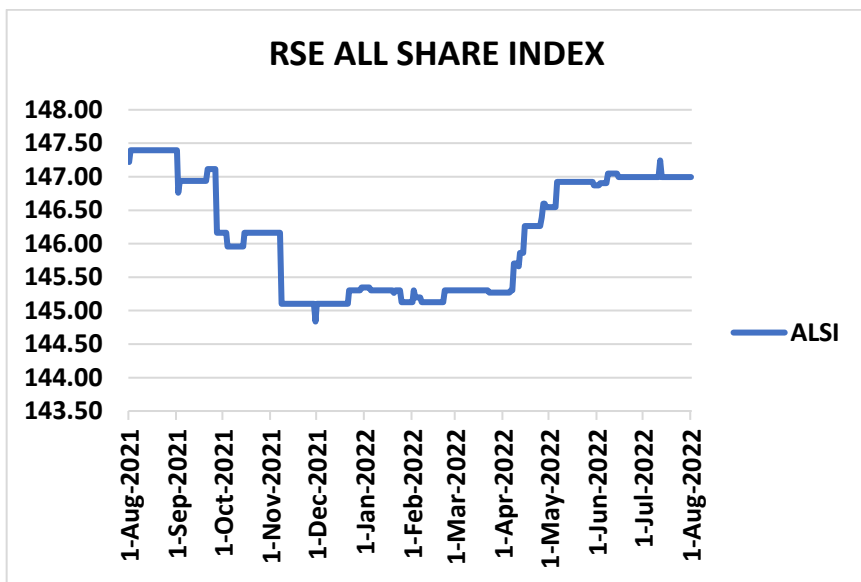
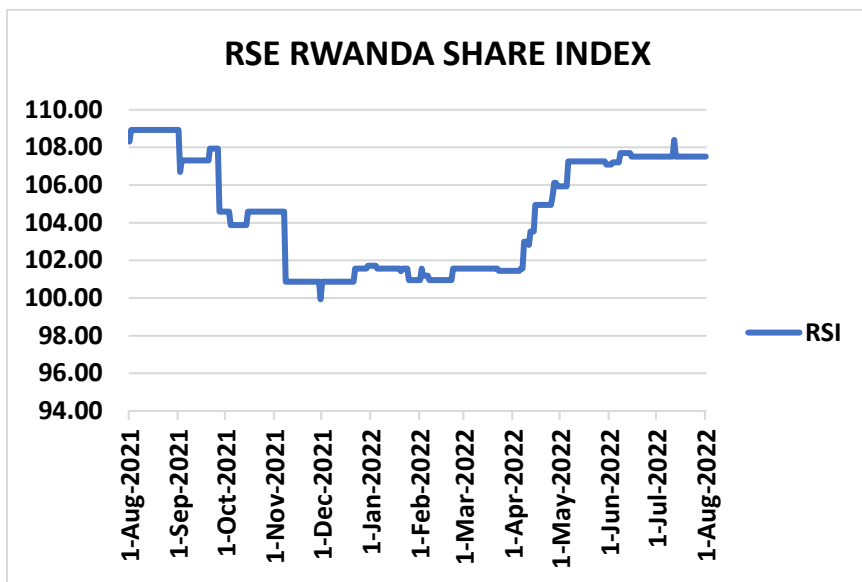
