



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 27<sup>TH</sup> NOVEMBER, 2019

### 1. Market overview

- Both RSI and ALSI went down 0.99 and 0.16 to close at 123.54 and 135.61 respectively.
- Today's trading session recorded a total of Frw 5,007,000 from 45,900 shares traded in 2 deals and Frw 16,320,000 worth of bond traded in 1 deal.
- CTL counter closed at Frw 70 (Frw 70 previous). The trading session recorded a total turnover of Frw 2,569,000 from 36,700 shares traded in 1 deal.
- BOK counter closed at Frw 265 (Frw 269 previous). The trading session recorded a total turnover of Frw 2,438,000 from 9,200 shares traded in 1 deal.
- Equities counters closed as follows: IMR: Frw 90; BLR: Frw 139; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

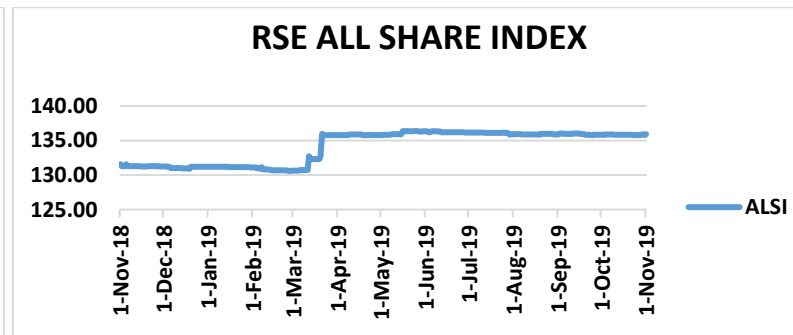
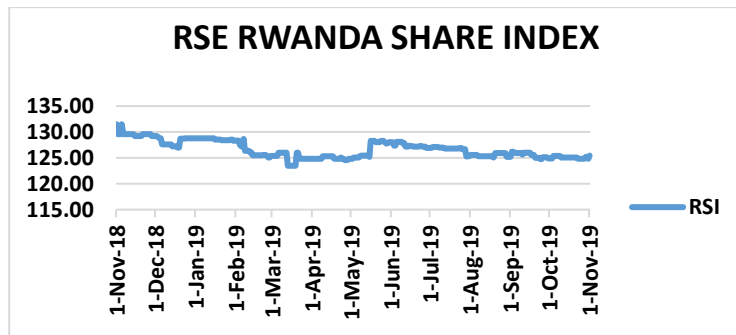
