



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 28TH OCTOBER 2020

1. Market overview

- Today's trading session recorded on the equities market a total of Frw 326,399,800 from 2,766,100 Bralirwa shares traded in 1 deal while the fixed income market was quiet.
- RSI and ALSI went down 1.40 and 0.26 points to close at 108.59 and 147.90 respectively.
- BLR counter closed at Frw 118 (Frw 124 previous). The trading session recorded a total turnover of Frw 326,399,800 from 2,766,100 shares traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 70; IMR: Frw 45; BOK: Frw 230; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 299,900 shares between Frw 230-240 and no bids. On BLR counter, there was an outstanding offer of 156,800 shares at Frw 136 and no bids. On CTL counter, there were outstanding offers of 68,400 shares between Frw 70-73 and no bids. On IMR counter, there was an outstanding offer of 30,000 shares at Frw 47 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

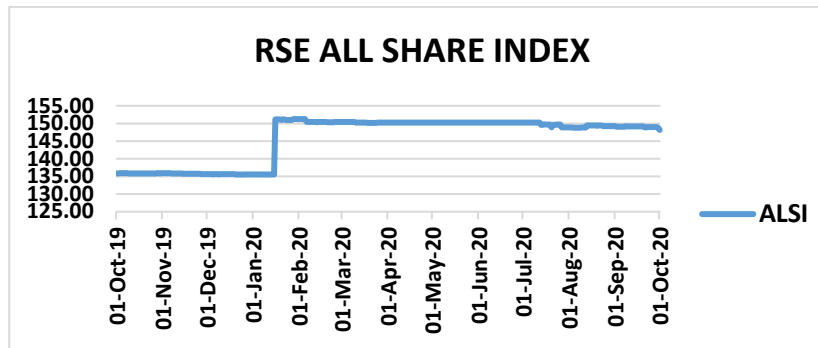
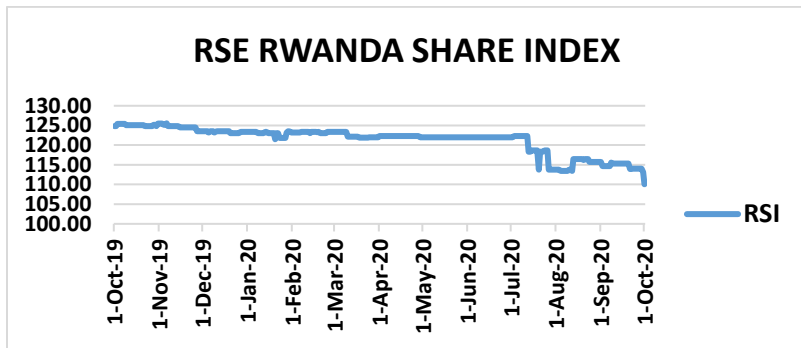
