



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 29<sup>TH</sup> DECEMBER 2021

### 1. Market overview

- The trading session recorded a total turnover of Frw 245,928,213 worth of bonds traded in 4 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- Equities counters closed as follows: BLR: Frw 125; BOK: Frw 250; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 40,000 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 652,000 shares between Frw 180-195 and no bids. On BLR counter, there was an outstanding offer of 10,000 shares at Frw 135 and an outstanding bid of 100,000 shares at Frw 116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 899,900 shares at Frw 45 and no bids.

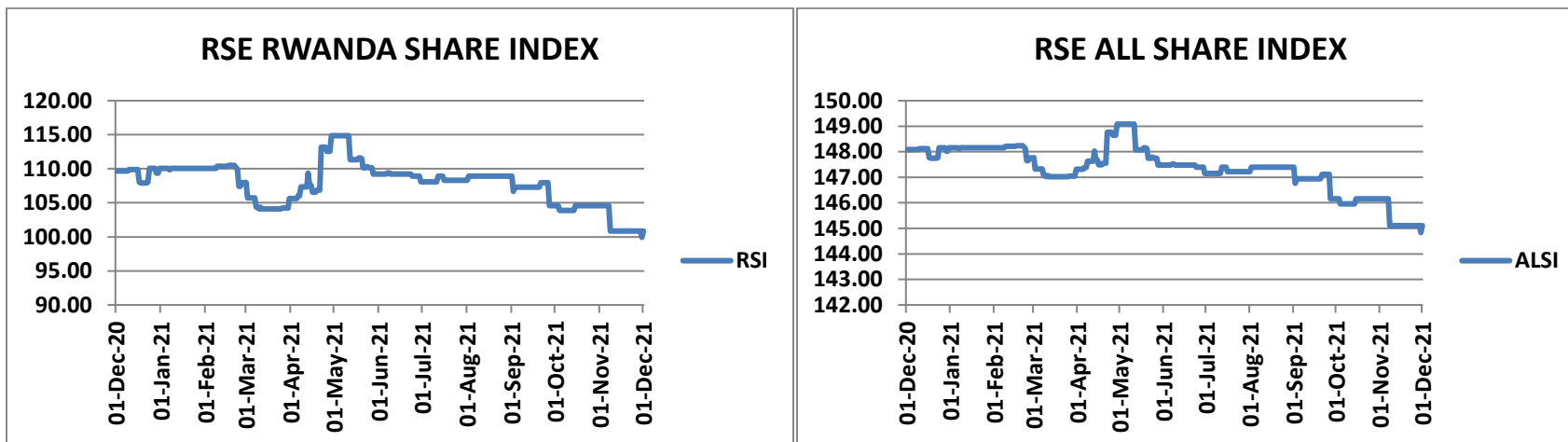
