



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 29TH JANUARY, 2020

1. Market overview

- Both RSI and ALSI went up 0.37 and 0.06 points to close at 123.54 and 151.25 respectively.
- Today's trading session recorded a total of Frw 1,356,000 from 7,900 shares traded in 5 deals.
- BOK counter closed at Frw 265 (Frw 265 previous). The trading session recorded a total turnover of Frw 626,000 from 2,400 shares traded in 3 deals.
- CTL counter closed at Frw 70 (Frw 65 previous). The trading session recorded a total turnover of Frw 35,000 from 500 shares traded in 1 deal.
- BLR counter closed at Frw 139 (Frw 139 previous). The trading session recorded a total turnover of Frw 695,000 from 5,000 shares traded in 1 deal.
- Equities counters closed as follows: IMR: Frw 90, EQTY: Frw 445; KCB: Frw 370; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

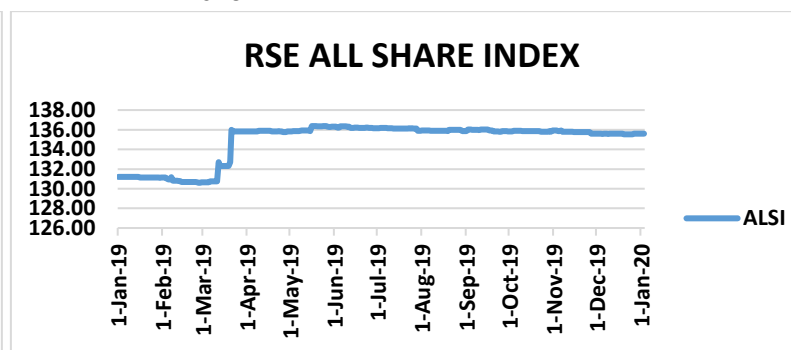
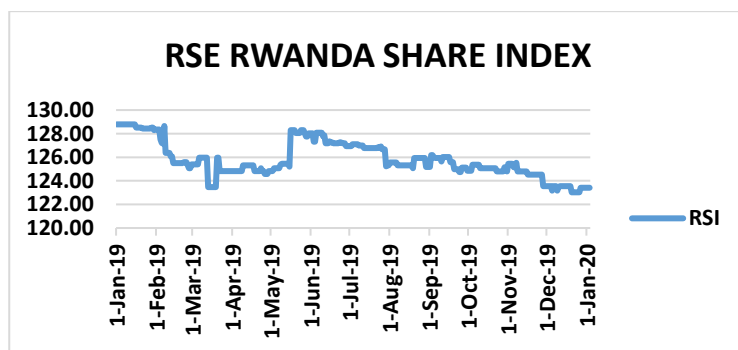
