



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 7TH JULY 2021

1. Market overview

- The trading session recorded a total turnover of Frw 546,988,000 worth of bonds traded in 4 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 108.07 and 147.15 respectively.
- Equities counters closed as follows: BLR: Frw 114; BOK: Frw 240; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 230; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; on BOK counter, there was an outstanding bid of 400 shares at Frw 235 and no offers. On MTNR counter, there were outstanding offers 898,900 shares between Frw 230-250 and no bids. On BLR counter, there were outstanding offers of 49,000 shares at Frw 120 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 18,700 shares at Frw 45 and no bids.

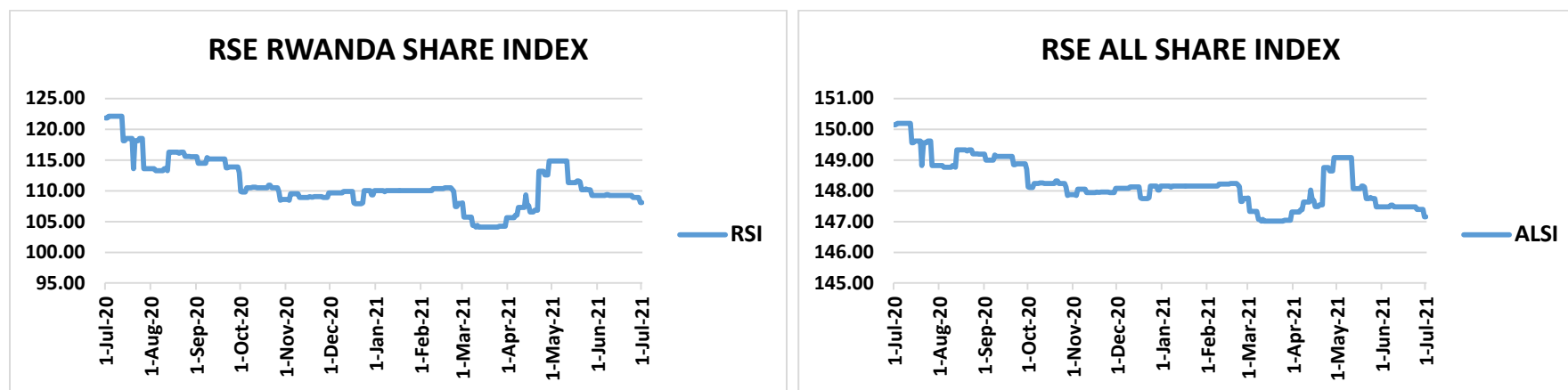

7. CORPORATE NEWS

- The BK Group Plc Annual General Meeting of shareholders approved the dividend payout ratio of 50% of the Group Net Income in respect of the 2020 financial year. However, following the recommendation from the Regulator (BNR), Directors do not recommend dividend payment for the year ended 31st December 2020 due to uncertainties arising from the COVID-19 pandemic and its impact on liquidity. This will be subject to further guidance from BNR.
- Nation Media Group Plc Annual General Meeting of shareholders has approved the buyback of up to ten percent (10%) of the Company's issued and paid-up share capital. The buyback is by way of open market purchases at KES 25 per ordinary share through the Nairobi Securities Exchange trading platform. The offer opened on 28th June 2021 and is expected to close on the earliest of the Company buying up to 10% of its issued share capital or at 3:00pm on Friday 24th September, 2021.
